**NG ENERGY PROVIDES BI-WEEKLY STATUS REPORT REGARDING MANAGEMENT
CEASE TRADE ORDER AND UPDATE**

Vancouver, British Columbia, June 15, 2021 – NG Energy International Corp. (“NGE” or the “Company”) (TSXV: **GASX**) (OTCQX: **GASXF**) is providing this update with respect to its previously announced management cease trade order (“MCTO”) issued by the British Columbia Securities Commission (“BCSC”) on May 4, 2021. The MCTO was issued in connection with the filing of the Company’s audited annual financial statements for the year ended December 31, 2020 and the related management's discussion and analysis (“MD&A”) and certifications (the “**Annual Filings**”).

As described in its prior update issued by NGE on June 1, 2021, the Company continues to work toward finalizing its Annual Filings and expects to be in a position to file in June.

The Company expects to file its interim financial statements for the three months ended March 31, 2021, the accompanying management’s discussion and analysis and the related CEO and CFO certifications after the Annual Filings are completed and filed.

The Company is providing this status update in accordance with National Policy 12-203 Management Cease Trade Orders (“**NP 12-203**”). The Company intends to follow the provisions of the Alternative Information Guidelines under NP 12-203, by issuing bi-weekly default status reports in the form of news releases. The Company confirms as of the date of this news release that there has been no material change in the information contained in the default announcement issued on May 4, 2021 and there is no other material information concerning the affairs of the Company that has not been generally disclosed.

During the MCTO, the general investing public will continue to be able to trade in the Company’s common shares listed on the TSX Venture Exchange. However, the Company's Chief Executive Officer and Chief Financial Officer will not be able to trade in the Company's shares until the Annual Filings have been filed.
